The Tourism Safety Initiative (Tsi) is a tourist safety & security programme facilitated by Tourism Business Council of South Africa (TBCSA).

It is a mechanism through which TBCSA co-ordinates and enables tourism businesses to speak with one voice on tourism safety & security matters.
